

## **CFILC Legislative Agenda 2010-2018**

The following is a document outlining the size and disposition of CFILC's Legislative Agenda for the years 2010-2018. The report on the current 2019-2020 Legislative Agenda is partial because we are in the first year of a 2-year session and because the majority of still-pending bills won't be finalized until the September 13<sup>th</sup> adjournment of session. In addition, following adjournment the Governor has 30 days to make his veto or signing decisions. Thus, the final report won't be available until mid-October.

The document lists CFILC's formal positions on bills for each session. Bills listed as INACTIVE were either unable to be voted off of the Suspense Files of the Assembly and Senate Appropriations Committees, failed in policy committee hearings, or were withdrawn or pulled by the authors before their hearings.
